GOLF MEMBERSHIP APPLICATION

TERMS & CONDITIONS

1. The applicant hereby applies for membership at Bulle Rock Golf Course (hereinafter referred to as the “BRGC”). This application will not be acted upon unless fully completed, initialed, signed and accompanied by cash, check or credit card for required dues or paid in full. The applicant understands that membership in BRGC and privileges to use the BRGC facilities shall terminate as defined herein and that all fees and charges applicable to membership are subject to change on an annual basis. Membership is contingent upon approval of BRGC in their sole discretion.
2. The applicant acknowledges and agrees to be bound by the terms and conditions as amended from time to time, in the sole discretion of BRGC. Membership privileges may be terminated for failure to abide by membership conditions.
3. The Term of each and every membership is one twelve (12) month period, beginning on either April 1 and ending on March 31 of the following year or beginning on July 1 and ending on June 30 of the following year. Membership for the Term will be first offered on a “first-come, first-served’ basis, subject to expiration at a date and time provide by BRGC; thereafter, the Club shall accept applications from new-members, with approval being subject to the BRGC’s discretion. The Member fees are non-refundable and due payable to BRGC upon execution of the Membership Agreement. Members may pay the Annual Fee or any other fee by cash, certified check, credit card or other form of guaranteed payment. At the end of the Term, the membership shall expire and BRGC shall have no obligation to offer any extension or renewal. Membership is limited in availability.
4. The applicant acknowledges and agrees to be jointly and severally responsible for all charges and expenses as may be incurred by the authorized member, family members and guests. The applicant further acknowledges that use of the BRGC’s facilities and any privilege or service incident to membership in BRGC is voluntary and that any use or acceptance of any service or privilege incident to membership is undertaken with knowledge of the risk of possible injury. The applicant hereby accepts any and all risk of injury to the member, member’s guests and family members sustained while using BRGC’s facilities. In accepting this risk of injury, the applicant understands that he or she is relieving BRGC and those employed by or affiliated with BRGC from any and all loss, cost, claims, injury, damage or liability sustained or incurred by the member, member’s guests and family members resulting from or arising out of any conduct or event connected with membership and use of any of BRGC’s facilities.
5. The applicant hereby acknowledges that membership in BRGC is not an investment in BRGC, nor does it provide an equity or ownership in the BRGC’s facilities which are owned solely by BRGC. Membership does not confer upon the applicant a vested or prescriptive right or easement to use BRGC’s facilities. BRGC reserves the right, in its sole discretion, to restrict or to otherwise reserve the BRGC’s facilities for maintenance, tournament or outing play and other special events. The applicant understands that a member has no right to vote or otherwise become involved in the management of BRGC. The payment of the fees, dues, state taxes, service charges, personal and other charges established is required to acquire and maintain membership privileges. With the exception of these membership charges, members are not subject to any liability or assessment for the costs and expenses of ownership or management of BRGC or its facilities.
6. A valid credit card must be kept on file at all times by the Member to keep membership enforce. Failure to do so may cause suspension of all membership benefits.

BRGC accepts MasterCard, Visa, Discover and American Express. Authorized credit card information may be changed by giving BRGC no less than thirty (30) days advance notice and execution of another authorization form. This authorization shall remain in effect for the duration of the Membership.

ADDITIONAL TERMS & CONDITIONS – The member affirms and agrees to the following:

- 1) Any golf membership at BRGC is non-refundable and non-transferable for any reason to include, but not limited to, injury or medical reasons either elective or otherwise with the exception of death.
- 2) BRGC will make every effort to secure the Member's personal belongings in either the Locker Room or Bag Storage areas. The Member releases BRGC from any financial responsibility whatsoever for lost or stolen items.
- 3) The monthly default credit amount is five hundred dollars (\$500). The Member may request a credit amount in excess of the default if elected subject to BRGC's sole discretion.
- 4) I affirm and understand that membership entitles me to 10% discounts in the Golf Shop and Gourmet Pub & Grill with the exception of Golf Shop sale items and/or already discounted Restaurant specials. I understand that my membership card is required to be used in order to receive such discounts and/or "open a ticket" in the Restaurant, Halfway House or Beverage Cart.

Membership may be paid either by lump sum (no finance charge) or 50% of the membership total (with finance charge on the balance) at the time of execution.
