ASSOCIATE GOLF MEMBERSHIP APPLICATION

TERMS & CONDITIONS

The applicant hereby applies for membership at Bulle Rock Golf Course (hereinafter referred to as the "BRGC"). This application will not be acted upon unless fully completed, initialed, signed and accompanied by the required dues paid in full. The applicant understands that membership in BRGC and privileges to use the BRGC facilities shall terminate as defined herein and that all fees and charges applicable to membership are subject to change on an annual basis. Membership is contingent upon approval of BRGC in their sole discretion.

The applicant acknowledges and agrees to be bound by the terms and conditions as amended from time to time, in the sole discretion of BRGC. Membership privileges may be terminated for failure to abide by membership conditions.

The Term of membership is one twelve (12) month period, beginning on either April 1 and ending on March 31 of the following year or beginning on July 1 and ending on June 30 of the following year. Membership for the Term will be offered on a "first-come, first-served" basis, subject to expiration at a date and time provided by BRGC; thereafter, the Club shall accept applications from new-members, with approval being subject to the BRGC's discretion. The Member fees are non-refundable and due payable to BRGC upon execution of the Membership Agreement. Members may pay the Annual Fee or any other fee by cash, check, credit card or other form of guaranteed payment. At the end of the Term, the membership shall expire and BRGC shall have no obligation to offer any extension or renewal. Membership is limited in availability.

The applicant acknowledges and agrees to be jointly and severally responsible for all charges and expenses as may be incurred by the authorized member, family members and authorized guests. The applicant further acknowledges that use of the BRGC's facilities and any privilege or service incident to membership in BRGC is voluntary and that any use or acceptance of any service or privilege incident to membership is undertaken with knowledge of the risk of possible injury. The applicant hereby accepts all risk of injury to the member, member's guests and family members sustained while using BRGC's facilities. In accepting this risk of injury, the applicant understands that he or she is relieving BRGC and those employed by or affiliated with BRGC from any and all loss, cost, claims, injury, damage, or liability sustained or incurred by the member, member's guests and family members resulting from or arising out of any conduct or event connected with membership and use of any of BRGC's facilities.

The applicant hereby acknowledges that membership in BRGC is not an investment in BRGC, nor does it provide an equity or ownership in the BRGC's facilities which are owned solely by BRGC. Membership does not confer upon the applicant a vested or prescriptive right or easement to use BRGC's facilities. BRGC reserves the right, in its sole discretion, to restrict or to otherwise reserve the BRGC's facilities for maintenance, tournament, or outing play and other special events. The applicant understands that a member has no right to vote or otherwise become involved in the management of BRGC. The payment of the fees, dues, state taxes, service charges, personal and other charges established is required to acquire and maintain membership privileges. Except for these membership charges, members are not subject to any liability or assessment for the costs and expenses of ownership or management of BRGC or its facilities.

Any member with an Elective Charge Privilege (see Page 3) must always have a valid credit card on file to keep the membership charging account active. Failure to do so may cause suspension of all membership benefits.

(INITIAL TO OPT IN) | ELECTIVE The undersigned hereby acknowledges and agrees that he/she wishes to be enrolled in BRGC's automated payment system – CHARGE PRIVILEGES. You will receive a monthly statement at the beginning of each month for any "charges to the Member Account." The system automatically charges the Member credit card on or around the 15th of each month. The automated payment system is a safe, secure and PCI compliant service that is provided free to all members. The undersigned represents that he or she has the full authority to enter into this Authorization. The undersigned acknowledges and agrees that the ability to make purchases or post charges is a privilege of membership that may be suspended at any time for non-payment. The undersigned agrees that in the event any charge is returned or declined by the card issuer, whether due to delinquency, over limit, suspension, closure, or error, the Member will pay the amount in question together with any fee incurred by BRGC as a result of such return or denial.

The monthly default credit amount with elective charge privilege is five hundred dollars (\$500). The Member may request a credit amount more than the default if elected subject to BRGC's sole discretion.

BRGC accepts MasterCard, Visa, Discover and American Express. Authorized credit card information may be changed by giving BRGC no less than thirty (30) days advance notice and execution of another authorization form. This authorization shall remain in effect for the duration of the Membership.
