## **ASSOCIATE GOLF MEMBERSHIP APPLICATION**

### **TERMS & CONDITIONS**

The applicant hereby applies for membership at Bulle Rock Golf Course (hereinafter referred to as the "BRGC"). This application will not be acted upon unless fully completed, initialed, signed and accompanied by the required dues paid in full. The applicant understands that membership in BRGC and privileges to use the BRGC facilities shall terminate as defined herein and that all fees and charges applicable to membership are subject to change on an annual basis. Membership is contingent upon approval of BRGC in their sole discretion.

The applicant acknowledges and agrees to be bound by the terms and conditions as amended from time to time, in the sole discretion of BRGC. Membership privileges may be terminated for failure to abide by membership conditions.

The Term of membership is \_\_\_\_\_, ending on March 31 of the following year or ending on June 30 of the following year. Membership for the Term will be offered on a "first-come, first-served" basis, subject to expiration at a date and time provided by BRGC; thereafter, the Club shall accept applications from new-members, with approval being subject to the BRGC's discretion. The Member fees are non-refundable and due payable to BRGC upon execution of the Membership Agreement. Members may pay the Annual Fee or any other fee by cash, check, credit card or other form of guaranteed payment. At the end of the Term, the membership shall expire and BRGC shall have no obligation to offer any extension or renewal. Membership is limited in availability.

The applicant acknowledges and agrees to be jointly and severally responsible for all charges and expenses as may be incurred by the authorized member, family members and authorized guests. The applicant further acknowledges that use of the BRGC's facilities and any privilege or service incident to membership in BRGC is voluntary and that any use or acceptance of any service or privilege incident to membership is undertaken with knowledge of the risk of possible injury. The applicant hereby accepts all risk of injury to the member, member's guests and family members sustained while using BRGC's facilities. In accepting this risk of injury, the applicant understands that he or she is relieving BRGC and those employed by or affiliated with BRGC from any and all loss, cost, claims, injury, damage, or liability sustained or incurred by the member, member's guests and family members resulting from or arising out of any conduct or event connected with membership and use of any of BRGC's facilities.

The applicant hereby acknowledges that membership in BRGC is not an investment in BRGC, nor does it provide an equity or ownership in the BRGC's facilities which are owned solely by BRGC. Membership does not confer upon the applicant a vested or prescriptive right or easement to use BRGC's facilities. BRGC reserves the right, in its sole discretion, to restrict or to otherwise reserve the BRGC's facilities for maintenance, tournament, or outing play and other special events. The applicant understands that a member has no right to vote or otherwise become involved in the management of BRGC. The payment of the fees, dues, state taxes, service charges, personal and other charges established is required to acquire and maintain membership privileges. Except for these membership charges, members are not subject to any liability or assessment for the costs and expenses of ownership or management of BRGC or its facilities.

Any member with an Elective Charge Privilege (see Page 3) must always have a valid credit card on file to keep the membership charging account active. Failure to do so may cause suspension of all membership benefits.

### **ADDITIONAL TERMS & CONDITIONS** – The member affirms and agrees to the following:

1) Any golf membership at BRGC is non-refundable and non-transferable for any reason to include, but not limited to, injury or medical reasons (either elective or otherwise) except for death.

2) The benefits of membership include: one (1) free green fee, reduced green fees for each round played, USGA handicap, membership card and bag tag, 30-day advance tee time booking, invitation to member only tournaments (additional fees will apply), and 10% discounts in the Golf Shop except for Golf Shop sale items.

**TEE TIME CANCELLATIONS** – The member accepts the responsibility of cancelling any unneeded tee time, for any reason, by 12PM the prior day to scheduled play. If the member 1) does not cancel by the deadline AND 2) does not find a replacement player(s); the member will incur “NO-SHOW FEE(S)” equivalent to the posted Resident Rate. Any such fees will be placed on the individual member’s account.

**FOR CLARITY**, when booking an online tee time at Bulle Rock, the original booking allows for all player names to be inserted. If players 2, 3, and/or 4 are not inserted at the time of booking, it is the booking player’s responsibility to email: brteetimes@gmail.com or call the Golf Shop with the additional player names by 12PM the day before play. Example: Any member that reserves a foursome (without other player names) and shows with less than four players will be charged the appropriate number of NO-SHOW FEES.

- a. Tee times may be cancelled via email using the original email confirmation. **Please note:** This will cancel the entire tee time for all players. The member and Golf Shop will receive a time-stamped cancellation email notice.
- b. Individual players may be cancelled by email to: brteetimes@gmail.com or by calling the Golf Shop. A cancelled individual player(s) will receive a time-stamped cancellation email notice.

An exception to NO-SHOW FEES will be made for significant rain and/or thunderstorms. **Cold, heat, wind, or day-of-play cart path restrictions will not be considered.**

Associate Membership fee must be paid in full prior to receiving the associated program benefits.

## AUTOMATED BILLING SUITE AND CREDIT CARD ENROLLMENT AUTHORIZATION
